Several options are available for Ballot remittance. Each option requires that you take specific action by the posted deadline to ensure your vote is counted. Please select ONE of the following voting options. Submission of multiple ballots (online and/or by mail) by a single lot will invalidate the vote submitted for said lot. Each lot may vote only once; multiple owners of a single property should discuss their voting preferences prior to submission then cast their vote collectively. The description of each action subject to member vote is included on the Ballot, a copy of which is enclosed and also posted to the website. Ballots received after the deadlines stated below will be invalid and will not count towards the voting outcome so please plan accordingly.

1. ONLINE BALLOT

<u>Online votes must be **submitted by 6:30pm on 7/30/24**</u> via the following link. If you intend to vote online, please do not complete the enclosed Ballot.

Please follow these steps to cast your ballot online:
